SUSTAINABLE WATER PROJECTS

As part of voluntary community work in a non-profit organisation or in connection with a student's (final) thesis or a doctoral dissertation at a university, you are dealing with subjects like the responsible and sustainable use of water and/or wastewater and/or the side products generated thereby (e.g. sewage sludge). Ideally, you are able to accurately depict in your project the value of water and wastewater. Your approach to solving the problem should look at the subject in its entirety and take into account the aspects of raw material scarcity and scarce energy.

WE FINANCIALLY SUPPORT

projects, whether executed locally or abroad, which concretely contribute to achieving the targets described above. You may as well submit ideas, these will be considered as well provided it is evident that at least one concrete example will be implemented with the use of the Huber Technology Foundation endowments.

FUNDS

The executive committee of the Huber Technology Foundation decides several times per year on the allocation and volume of funds. Funds are limited to the maximum of 70% of the project costs and the maximum amount of 5,000.00€.

APPLICATION

Applications can electronically be filed to the Huber Technology Foundation informally and at any time and their volume of text should not exceed 3 pages.

Application papers should describe how the project contributes to the appreciation of the element water and explain what constitutes a sustainable and future-oriented aspect. Both the overall project costs and the volume of the funds applied for should be specified.

HUBER TECHNOLOGY PREMIUM PROJECT

In addition, the best projects will be selected within the period of one year and the winners receive prizes which the Huber Technology Foundation plans to award in an official awards ceremony. As an alternative, prizes can be awarded by a subsidiary of Huber SE abroad.



PATRONAGE

The award of the prize "HUBER TECHNOLOGY PREMIUM PROJECT" is under the patronage of the Bavarian Ministry of the Environment.

TERMS AND PROVISIONS

In case a project is funded by the Huber Technology Foundation, the persons and/or institutions involved agree that the Foundation shall be entitled to name the project in its own publications. All images shall become the property of the Foundation. All rights remain with the applicants. Submitted proposals will be treated confidentially. The executive committee's decision will be final and unappealable. The possibility of recourse to legal action is excluded.

HUBER TECHNOLOGY FOUNDATION

The Foundation supports science and research as well as projects related to the 'sustainable use of water', taking into account also climate change and creation of awareness. The Foundation pursues exclusively and directly non-commercial objects.

The Foundation's mission is achieved in particular through the following measures::

- 'Huber Technology Premium Project' award
The aim of this award is to honour special achievements of students and doctoral researchers in the field of 'sustainable use of water' and thus promote the education of young engineers, especially students and doctoral researchers, taking into account the international aspect. Students in Germany and abroad are invited to submit their proposals.
- Further purposes of the Foundation are the complete or partial funding of projects which serve the sustainable use and appreciation of the resource water and sustainability in general. In particular, the Foundation financially supports the organisation of or participation in conferences, workshops and seminars as well as investments in water or climate projects in Germany and abroad.

The Huber Technology Foundation can also provide physical or financial funds to tax-privileged bodies, institutions and foundations or other suitable public authorities provided these organisations use the money to support measures that are in accordance with the purposes specified above.
